The October 27, 2021, meeting was held pursuant to the Bylaws. All Directors were present. Also, present were Kevin Doddridge, CEO/General Manager, Attorney, James E. Woods, and Staff.

President Pat Woods called the meeting to order at 3:15 p.m.

Pursuant to the bylaws a quorum was not reached at the Annual Meeting. The three Directors, (Director Don Dickerson from District 2, Director Morris Thompson from District 6, and Director Julie Niblett from District 9), will serve until their terms are completed. Motion by Director Phil Lachaussee and Motion seconded by Director Joan Childress to officially seat Director Don Dickerson for District 2, Director Morris Thompson for District 6, and Director Julie Niblett for District 9 each for a three-year term.
